

2024 Community Outreach Ticket Guidelines

Deadline: Monday, March 18th, 11:00 p.m. CT

The New Orleans Jazz & Heritage Festival and Foundation's **Community Outreach Ticket** program provides tickets to the New Orleans Jazz & Heritage Festival presented by Shell (Jazz Fest), the Foundation's main fundraising event.

The purpose of Community Outreach Tickets is to provide access to Jazz Fest for those Louisiana residents who <u>otherwise</u> could not afford to attend the <u>festival</u>. Only <u>organizations in Louisiana</u> are eligible to apply.

Community Outreach tickets are distributed through *Louisiana* nonprofit social service organizations that provide direct, ongoing services to low-income residents of Louisiana. These may include educational, religious, government, and community agencies – but only those that provide direct, ongoing services to low-income clients.

Applying organizations must provide details on the types of services they provide and demographic data on their clientele. Any tickets received by these organizations <u>may be used only by the people who receive services from those organizations.</u>

Tickets are **NOT** to be used by current or former staff members, board members, donors, sponsors, or volunteers of those groups, or their families, except in cases where a chaperone is required.

If any applicants for Community Outreach Tickets need to use tickets to provide chaperones, they <u>must state clearly in</u> their application how many tickets must be <u>used for that purpose and explain why this is necessary</u>.

The tickets may not be sold in any way. They are not to be used as raffle items or for fundraising purposes, or as rewards for volunteers. They are to be distributed based on financial need and availability and, in certain approved cases, as rewards or incentives for the clients' good behavior.

Any recipients of Community Outreach Tickets who are found to violate the letter or spirit of these guidelines will be permanently barred from receiving tickets through this program in the future.

ONLY REQUESTS THAT ADHERE TO THESE GUIDELINES WILL BE CONSIDERED.

Note: Only organizations in Louisiana are eligible to apply.

Required Materials:

- All applications must be accompanied by the following:
 - A letter on the applying organization's letterhead signed by the chief executive officer.
 - o Proof of Louisiana state nonprofit status or an IRS letter proving federal 501(c)3 nonprofit status

ONLY REQUESTS THAT ADHERE TO THESE GUIDELINES WILL BE CONSIDERED.

Eligible Recipients

- 1. <u>Public and non-profit private schools</u> offering grades 9-12 (with proof of nonprofit status and letter signed by the head of school) can apply for tickets to be used by students as rewards for good grades or outstanding behavior.
- 2. <u>Nonprofit organizations</u> within the state of Louisiana that provide direct, ongoing social services to low-income residents of Louisiana; must provide proof of federal 501(c)(3) *or* Louisiana nonprofit status; 501(c)(4) social welfare organizations are <u>not</u> eligible. Nonprofit status must be current and/or active. Inactive organizations are not eligible.
 - a. Universities
 - b. Charities
 - c. Neighborhood
- 3. **Religious organizations** (with proof of nonprofit status) that provide direct, ongoing social services to low-income residents of Louisiana.
- 4. Government agencies that provide direct services to low-income residents (with letter on official stationery).
 - a. Housing authorities
 - b. Recreation programs

Ineligible Applicants- We will not grant Community Outreach Tickets to the following:

- 1. Privately owned for-profit businesses.
- 2. Kindergarten through 8th grade schools and classes. <u>Schools that serve fourth through eighth grades may apply to participate in the "School Day at Jazz Fest" program. Contact Festival Productions, Inc., by calling (504) 410-4100, or by sending an email to: schoolday@nojazzfest.com.</u>
- 3. Individuals.
- 4. Staff, employees, board members, volunteers, or agents of city or state government departments/agencies and their family members (although applications from government agencies that provide services to the needy are eligible).
- 5. Organizations based outside the state of Louisiana.
- 6. 501(c)(4) social welfare organizations.
- 7. Organizations requesting tickets to be used by or for the following:
 - Board members
 - Donors/Benefactors
 - Paid contract employees
 - Contractors or consultants
 - Dues-paying members
 - Executive staff
 - Staff or employees (except when chaperones are required to assist those who receive the agency's services)
 - Volunteers
 - Family members of staff, board, donors, benefactors, contractors, and consultants for the applying organization
 - Offices of elected officials and their staff members
 - Fraternal organizations or other social/benevolent groups that do not provide direct, ongoing social services to low-income individuals, social aid and pleasure clubs
 - Business development organizations or associations
 - Nonprofits that only provide arts or other educational programming and do not provide direct, ongoing social services to low-income individuals
 - o Booster clubs or fundraising arms of nonprofit organizations
 - Organizations that charge clients a fee or tuition for services

^{**}Any agencies/organizations applying without proof of nonprofit status <u>will NOT be eligible</u>. The nonprofit status of all applying organizations <u>must be current</u>.

- Members or staff of city or state government offices in the Legislative, Executive, or Judicial branches, other than agencies whose sole role is to provide direct, ongoing social services to low-income residents of Louisiana
- Raffles
- o Fraternities or Sororities
- Contest or prize giveaways
- Fundraising activities of <u>any kind</u>
- o Promotional uses of any kind

Application Guidelines:

- All applicants must fill out the <u>application form</u> and submit the required supplemental materials.
- Applications should be filled out online through the <u>Community Outreach Tickets web site</u>.
- Those unable to access the online application form may call the Foundation office for assistance at 504-558-6100. The online application form is *strongly encouraged and preferred*.
- All applications **must be** completed and received **by 5 p.m. CST on Monday, March 18**th to be considered for an award of Community Outreach Tickets.
- Community Outreach Tickets are for use by those who otherwise could not attend Jazz Fest for financial reasons.
 - Community Outreach Tickets must be distributed to those who receive an organization's services.
 - Community Outreach Tickets are NOT for organization board members, donors, employees, contractors, volunteers, or family or any others listed as ineligible in these guidelines.
 - o Community Outreach Tickets <u>may not be sold</u> or used for fundraising purposes.
 - o If an organization violates the <u>intent</u> of the Community Outreach Tickets program and its guidelines, the violating organization will be permanently barred from receiving Community Outreach Tickets in the future.
- Organizations seeking Community Outreach Tickets may submit only one (1) application per year.
- Applications, including those submitted online, must be accompanied by the following supporting documents:
 - For all but government service agencies, a copy of the letter from the Internal Revenue Service verifying 501(c)(3) status, or proof of State of Louisiana non-profit status through the Secretary of State's website.
 Applications without proof of nonprofit status will be disqualified.

AND

- A letter on the organization's official stationery signed by the highest authorizing official of the organization that explains the work of the organization and to whom tickets will be distributed. Request letters signed by anyone other than the highest authorizing official or not on official stationery will be disqualified.
- Community Outreach Ticket requests are limited to a maximum total of 30 tickets. Tickets will be awarded based on availability, with **priority given to new applicants**. We regret that we cannot honor all requests, and in most cases we cannot supply the number of tickets requested. A past history of receiving tickets is **not** a guarantee that applicants will receive tickets this year or in the future.
- Community Outreach Ticket applicants will be notified by e-mail when the applications have been reviewed and processed.
- Tickets do not include Saturday admission.
- Tickets are weekend specific and are ordered based on applicant's response on the application.
- Tickets for approved applications will be available for pick-up at a date that will later be specified. <u>Tickets not</u> picked up on the specified date will be forfeited.
